Subject: Public Art Map

Recommended Action:

Review and approve the digital public art map.

Background:

The current City of San Ramon Public Art Brochure was created and approved by the Arts Advisory Committee on June 19, 2002. The brochure is 11 inches by 35 inches and folded into an eight-fold booklet that includes a map, address, and descriptions of all the public art in San Ramon. The brochure also includes some photos of the public art pieces. The brochure was printed and distributed at the front counters in City facilities.

The Arts Advisory Committee set a goal in their 2017 Annual Report to the City Council to:

"Update and make available to the public, the San Ramon Public Art Map."

The Arts Advisory Committee discussed the San Ramon Public Art Map at their regular meetings on March 9, May 16, July 18, November 28, 2018, and May 15, 2019. The committee endorsed the idea of creating a digital online public art map that contains the location and pictures for each piece of public art in San Ramon rather than a print version. They recommended that the map reflect the permanent and temporary public art in San Ramon, be updated on a regular basis, and be presented in a format that is user-friendly and visually appealing. Arts Advisory Committee Members assisted in updating the content by visiting the artwork to verify the location, note the condition of the artwork and took pictures. Staff has worked with the Engineering Department staff to develop the digital map which is located at the following web address: https://arcg.is/1SLaDH. The Arts Advisory Committee reviewed the draft and provided feedback at their May 15, 2019 meeting.

Fiscal Impact:

None at this time

Steps Following Review:

Staff will incorporate additional feedback from the Arts Advisory Committee. Once approved the public art map will be forwarded to the Parks & Community Services Commission for approval. Upon approval from the Parks & Community Services Commission, staff will update the public art webpage on the city website to include the new public art map.

Subject: Public Art Marketing Discussion

Recommended Action:

Review the draft public art publicity options and provide feedback to staff.

Background:

The City of San Ramon Public Art Program is has added the Utility Box Public Art Program and an online Public Art Map within the last year. With these new components, the Public Art Program has several visible components which can be leveraged to create a marketing campaign to build an awareness of public art in San Ramon. The marketing campaign will replace the previous public art brochure and may include print and online media.

Staff has developed several options for the Arts Advisory Committee to review and provide additional feedback.

Option 1: Create a Public Art Rack Card. The 4"x11" card can be produced in full color and include public art photos and general information on the Public Art Program. The card will direct people to the website to access the public art map and for additional information on public art in San Ramon.

Option 2: Create a shortened URL on the City's website for public art at www.sanramon.ca.gov/publicart or purchase a domain name such as www.sanramonpublicart.com. A shortened URL or dedicated domain name will help the public easily remember and access to the public art web content. The public art website will be key to distributing information on the Public Art Program.

Option 3: Conduct a Social Media Campaign. Utilize Facebook, Instagram and Nextdoor to highlight the Public Art Program. The campaign may include photos of public art pieces, locations of where people can visit them, and background information on the piece and/or artist.

Fiscal Impact:

The cost will be determined by the final marketing plan and components. Parks and Community Services currently has \$1,100 allocated to public art marketing for 2019/2020.

Steps Following Review:

Staff will incorporate feedback from the Arts Advisory Committee to create a public arts marketing plan including publicity for the public art map. The marketing plan will be presented at a future Arts Advisory Committee Meeting and forwarded to the Parks & Community Services Commission for approval.
